

## Official Promotion Rules and Disclaimers- Sweepstakes

**ELIGIBILITY:** Sweepstakes are open to current Riverset Credit Union Members ("Members") who are legal residents of the fifty (50) United States, excluding Puerto Rico and other US territories. Riverset Credit Union Officers, Employees, Directors, Supervisory Committee Members, agents, representatives, prize suppliers, and promotional and advertising agencies, and their spouses, parents, children, siblings, and their respective spouses, and individuals living in the same households as any of these individuals, are not eligible to enter or win. All federal, state, and local laws and regulations apply. Void where prohibited or restricted. By entering any Sweepstakes, participants agree to be bound by these Official Promotion Rules and Disclaimers and the decisions of the Riverset Credit Union.

**ODDS:** Odds of winning prizes depend on the total number of eligible entries received, unless otherwise noted.

**HOW TO ENTER BY MAIL IN ENTRY:** No purchase is necessary to win. Entries received through participation in the Sweepstakes or entries received via mail will have an equal chance of winning. Any Member may enter any Sweepstakes by hand-printing his/her name, address, day and evening phone numbers, email address (if any), age and the name of the Sweepstakes, on a 3" x 5" piece of paper and mail it with proper postage to: Riverset Credit Union, 53 South 10th Street, Pittsburgh, PA 15203. You will receive one (1) entry into the Sweepstakes. All mail-in entries must be handwritten. All mail-in entries must be received by Riverset Credit Union prior to the close of business on the final date of the Sweepstakes entry period. All entries become the exclusive property of Riverset Credit Union, and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Riverset Credit Union. Riverset Credit Union is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

**DRAWINGS AND PRIZE REDEMPTION:** Riverset Credit Union will randomly select the Sweepstakes winner(s) from all eligible entries received and such selection shall be final and binding in all matters. Riverset Credit Union will notify each winner (or their parent/guardian) via e-mail, phone, or U.S. Mail and provide an Affidavit of Eligibility and Release. If the winner (or their parent/guardian) fails or refuses to sign and return the Affidavit of Eligibility and Release within the timeframe stated therein, the winner will forfeit the prize. An alternate winner will be selected from the remaining eligible entries. Any prize notification or prize returned as undeliverable will be forfeited and awarded to an alternate winner.

**PRIZES:** Prizes shall be identified in each Sweepstakes Announcement. The winner is responsible for any federal, state, and local taxes associated with acceptance and use of any prize or incentive. Prizes are not transferable. No substitution of prizes permitted.
